SWEARING IN OF MAYOR

Comments from Mayor Mignogna:

First of all, I thank everybody for coming this evening. We really appreciate your being here.

To my fellow committeemen, our honored guests this evening, and friends, thank you for once again allowing me the privilege of serving as the Mayor of Voorhees Township. Amazingly enough, this will be my eighth year as your mayor and as I say every year, I will never take the privilege lightly. I will work hard to make you proud, to do the right thing, and to be a good ambassador for Voorhees Township.

I want to congratulate my fellow Committeeman, Harry Platt, on his election. This is the fourth time that I had the privilege of running with Harry for Township Committee. We worked very hard, and we've been successful, and it's been my honor not only to run with him, but to serve with him for the last nine years.

Before we move forward, I just want to reflect a little bit about the last year. Two thousand eleven was quite an eventful year for Voorhees Township. We had the openings of two of the biggest projects in the history of the Township, in the matter of a couple of weeks of each other -our new Virtua Medical facility, which has become really the jewel of Route 73 as a state-of-the art, half billion dollar medical project and of course, this, The Voorhees Town Center. With the incorporation of our Town Hall into the town center, it's quickly becoming the downtown that we always envisioned it would be. With the opening of restaurants like "Firecreek" and "Dog House Cafe", as well as the community events that they run here, little by little, as I like to say, it is becoming the heartbeat of Voorhees Township.

So much so that this past June we were privileged to host a delegation of eighteen people from South Korea, who actually came to Voorhees to study the idea of incorporating Town Hall into a Town Center. It was a unique opportunity for us to exchange ideas. Usually those kinds of things are done on a local level but this time we had chance to do it on international level. So, we were very flattered that they would take the time, the expense, to come here to study what we believe is a wonderful concept here in Voorhees Township.

We continue to improve our infrastructure in Voorhees Township. We commissioned our ten million dollar sewer project along Route 73 and Dutchtown Road, paid for by Virtua. We connected the Regency Sewer Extension allowing residents no longer to have to rely on those unsightly grinders in that neighborhood.

We continue with our five-year road program, repaving Victor Boulevard, Franklin Place, Abby Road, Foxton Court, Harwood Place, and Woodland Glenn. We put sidewalks on Centennial Boulevard to connect the Main Street complex to Connelly Park and we put sidewalks along 561 connecting Lyons Gate to the Eagle Plaza area. Our park system is still the top park system in the area. We renovated the Rabinowitz baseball complex with new turf, new dugouts, and all with the use of a grant. We expanded the Lions Lake parking facility, an area that gets a lot of use by our softball organizations and by groups using our banquet facility.

We worked hard to make our government more efficient and more accessible. This, our new Town Hall, we're very proud of. It allows our local government employees to serve our public and our residents more efficiently and more safely. This courtroom, as you look around it, has a new sound system, a new camera system and a new power point capability that allows our residents to better participate and view not only committee meetings, but zoning board meetings, and planning board meetings.

We're proud to have upgraded and put out a new website this year. Just recently, we opened our website, which is much more user friendly, with much more information for our residents. I want to give a special thanks to our Municipal Clerk, Jeanette Schelberg for putting in a lot of time and a lot of effort, for meeting with people, for meeting with the department heads, to make sure everybody had something to say in how the whole process was done. So Jeanette, "Thank you very much."

We continue to participate in Nixle, with more residents than ever - giving us immediate contact with our residents to give them emergency announcements or to let them know about community events. We continued with our anonymous police crime tip line. We worked hard to continue to protect our environment. Just last week, we purchased an additional 20 acres for open space in the Ashland neighborhood of Voorhees Township. What this means is that since 2003 we have protected 223 acres in Voorhees Township for open space. We are very proud of that.

We continue to work with Rutgers and VCEF on the former Buzby Landfill to make it a community destination - the Voorhees Environmental Park.

As always, our most challenging job was to balance tax stability with maintaining the high quality of life that our residents have come to deserve and enjoy. We did it in two ways, by controlling spending and by generating tax revenue. How do we control spending? We have twenty-five fewer full-time employees at the township than we had in 2003. We partnered with an energy company to buy our utilities directly from the provider, saving \$125,000.00 a year. We joined sensible shared services. We entered the county dispatch saving \$400,000.00 a year. We entered into an agreement with seven other municipalities, including Cherry Hill, the largest such agreement of its kind for trash disposal, saving our township \$138,000.00. We partnered with Eastern High School for snow removal, and Gibbsboro for leaf removal. While we joined many sensible shared services, I say as I have said before, and I think my fellow committeemen support me, we have the finest police force in the area and we will not join the County Police Force.

We have created additional revenue by working with our EDC and VBA. www.prospector.com is a vehicle that allows us to advertise world wide, available commercial property here in Voorhees Township. Just in the two years that we have had this, we've had 150,000 hits on our website.

We continue in the state program of Live Where You Work. That gives financial incentives to first-time buyers for those who work in Voorhees, to live here.

We worked again with VBA and EDC on our business retention task force to help existing businesses in Voorhees Township thrive. Generating new business here in Voorhees Township is a team effort. An effort not only from the committeemen, but EDC, and VBA, and because of those efforts many new jobs were generated in Voorhees this year.

A thousand new jobs came with the opening of Virtua. Sony Music holdings brought fifty-four new jobs to Voorhees. American Water's expansion brought another forty jobs to Voorhees. Magellan Hill Technologies brought fifteen more jobs to Voorhees. And we are also happy to welcome traditional family businesses to Voorhees Township. Thrifty Sisters came to Voorhees. Giggles and Wiggles Pet Grooming came to Voorhees. Crazy Susie's Cookies and my good friend Pat Malonese opened his pizzeria here in Voorhees. I am proud to say in 2011 we brought in over 1600 new jobs to Voorhees Township.

We continued with many successful traditions. Our Summer Twilight Series was bigger and better than ever with our four shows and movies in the park. We had our sixth annual Halloween-in-the-Park, and this year it was Halloween in the *Parking Lot*. Because of the rain, our public works guys did a wonderful job moving it from the park up to the parking lot.

Our diversity committee many, of whom are here this evening, put on another successful International Day, giving us an opportunity for all those in Voorhees Township to celebrate our differences. We also started a new tradition, a holiday parade, right here in the Voorhees Town Center. I got to ride in a Mustang with Santa Claus. A special moment.

As I say every year, we live in a very special town, but it's special because of the wonderful people and wonderful causes that we have here in Voorhees. The continuing causes of groups like the *Little Rock Foundation* that fights for children with visual impairments, our *Alicia Rose Foundation* who finally opened a teen center in Voorhees. Yes very nice. They opened a teen center in the new Virtua complex and we're very proud of that. Groups like *Speak* who advocate on behalf of special needs kids. Groups like our *Breakfast Rotary*, who work hard to make our township better and last year honored our own Gisele DiNatale as citizen of the year and Rich Miller, CEO of Virtua, as our business person of the year.

While it was a year of many happy moments, we had a very important loss here in Voorhees Township when we lost our good friend John Maurer. Many of you know John Maurer, many of you don't know John Maurer. John Maurer was the Director of Public Works here in Voorhees Township who unfortunately on June 11, passed away at the all too young age OF 118. John started out as a supervisor here in Voorhees in 1990. He was promoted to Director of Buildings and Grounds and ultimately Director of Public Works. John was the guy who, when it snowed, would work forty-eight straight hours to make sure our roads were safe for our families. John was the guy who oversaw our township conversion to single-stream recycling. John's greatest passion was the maintenance and the protection of our parks and our open space. He turned the former Lafferty Asphalt Plant into what we now know as the 49-acre oasis of Connolly Park. Voorhees is a better place because of John Maurer. I'm a better man because for knowing John Maurer. We will miss him dearly.

Some memorable, personable moments - countless lunches, dinners, grand openings, trophy presentations, and weddings. But the two grand openings that I will remember the most are the grand opening of Virtua and the grand opening of this, our Voorhees Town Center, because I was privileged to be part of the planning, privileged to watch both projects grow from infancy, and privileged to be Mayor when they both opened.

Another memorable moment happened on the eve of Hurricane Irene when I was very proud to sit with our emergency command team leaders at Kresson Station. Our Chief of Police, our Chief of the Fire Department, and our emergency management personnel, who worked like a well-oiled machine before the storm hit to make sure that our people were kept safe, and they did that, and they kept our residents safe and for that I am very proud. A very special moment for me even to be there to watch that happen.

On July 7 I was proud to be part of the unveiling of a Wall of Honor at Yardley Commons, dedicated to the war veterans from World War II, Korea, and Vietnam. We heard stories, shared laughs, and shared some tears.

And on a glorious Sunday afternoon, Voorhees marked the tenth anniversary of the terrorist attacks of September 11, 2001. At 1 pm, with church bells ringing and sirens blaring, our voices fell silent as part of a national moment of remembrance. We will never forget them.

We look forward to a busy, exciting 2012. Virtua will continue to grow with the opening of their ambulatory care center. More jobs and more tax revenue for Voorhees Township. This facility and this Town Center will continue to thrive with the opening of restaurants, like Catelli's Duo and the opening of a farmers' market in the spring. We're very excited about that.

This committee will continue to work hard to control taxes and still supply a wonderful quality of life for our residents. We're going to move to a side-arm recycling pick-up, which will allow us to do the same type of work with less man power. We will continue with sensible shared services agreements.

We are about to enter into an agreement with Laurel Springs to pick-up their trash and will continue negotiations with both Cherry Hill and Evesham on a monthly basis to find other sensible shared services agreement. We have a very, very strong police force. While other townships are laying off police officers, I'm proud to say that we are hiring two more police officers for our township.

We'll continue with our five-year road program. You'll be happy to know that Route 561 will be paved this coming summer of 2012. We'll continue making our parks and our recreational facilities the best in South Jersey. We'll continue working hard to protect our environment working with VCEF and Rutgers to make sure that the former Buzby Landfill becomes a community destination, and we will continue with our community events, making our summer series and Halloween-in-the-Park bigger and better than ever. This year more than ever we will partner with our schools, to make sure that our children receive the best education and to make sure that we do not have Charter Schools here in Voorhees Township.

A couple of thank yous. I want to thank the township employees for their hard work and their dedication every year, and I want to thank our professionals who do a great job here. They often make me and other committeemen look very good and sometimes it isn't easy. I want to thank the volunteers on all of our boards, our committees, our commissions, because they give us their most valuable asset, which is their time. I want to thank my brother, for swearing me in. I want to thank my daughter, for singing the National Anthem. She continues to devote her life to working with sick children at Children's Hospital and I couldn't be more proud. Remember, I will always be the first man who fell in love with you. My son is not here because I'm proud to say he graduated from Salisbury University and he's actually starting courses for his master's degree tonight at Rutgers University. So I would much rather have him there than here with us, even though I miss him. My baby Marie, who's a sophomore at Lehigh, she's is thriving academically and athletically. Third in the nation in the defense saves, and second team all conference, but you'll always be my baby.

I have been on Township Committee for nine years. I have been privileged to be your Mayor for seven. I have always been smart enough to surround myself with good people, with loyal people, and with smart people. I want to share a secret with you. During all this time, I've had a guardian angel who has been watching over me, and that's my Dad. I hope that I made him proud. It was nice to see Bernie - the moment you shared with Harry tonight. The bond between father and son is so special. To see you guys have that moment was very special. I never had that moment with my dad because I got involved after he had passed on. I would like to think that many of the good things that I have done, and my brother has done, could be attributed to my father as being our guardian angel.

Two thousand twelve is going to be a very special year because I know I'm going to be doing the right thing. I'm going to be watched over, because this year I have two guardian angels, because as many of you know, my mom passed away, but I know she's here with me tonight and I hope that she's proud.

So thank you for letting me be your Mayor again and Happy New Year.
