Mr. DiNatale stated that he is conflicted with this resolution. While he is absolutely in favor of the improvements that have been done at Rabinowitz Field over the last ten years, as well as the improvements to all our fields, he is concerned over the amount of money that is being spent. While he is in favor of improving the field, he is concerned about doing it during a time when money is tight for the township and for the residents. He would like to investigate whether there is a way to improve the field without costing taxpayers money.

He stated that he wants it but does not think we can afford it. Because of that, he is not going to vote against it, because he wants it; he is not going to vote for it, because he doesn't want to spend that much money for it, so he is going to abstain.

Mr. Friedman stated that no one wants to spend a lot of taxpayer money on items. He wishes they were all free, but they aren't. He is voting in favor of this because it is an investment in our Township and community. It is a glowing item in our town, so to protect the investment we have done over the years, this is a necessity. It was explained in caucus that a portion of this money, about \$16,000, must be spent for a backstop so foul balls don't hit spectators. If we were to delay this and then install it in a few years, it would be cost prohibitive because we would have to go back and disturb the field we put in the year before. No one wants to spend a lot of money; however, certain things require investment and smart thinking. In this case, several bids were submitted and this was the lowest bid, unlike other areas where we have chosen the highest bid, this is the lowest bid and this is the recommended bid.

Mr. DiNatale stated that he agrees with Mr. Friedman that we want to keep our fields in the best shape possible, but perhaps he (Mr. DiNatale) being from a different walk of life than Mr. Friedman, that is a middle class/blue collar guy from Pennsauken, he feels that this amount of money is – not a lot- but more than what we have and he likes to spend within our means. He believes the improvements are necessary but thinks it could have been done for a little bit less.
