

## After Action Summary Report

The purpose of this project was to secure the requisite number of signatures from Voorhees Township voters to authorize a public hearing regarding the proposed dissolution of the Voorhees Fire District.

According to the Camden County Clerk's office, as of November 21, 2016, there are 20,503 registered voters in Voorhees Township (See Document 1, titled "Voorhees Registration Report 11\_21\_2016"). The required number of signatures to petition the Township is 5% of the total number of registered voters, or 1,026 signatures.

Volunteers began gathering signatures on Saturday, November 12, 2016 by visiting voters door-to-door. We used a voter registration list obtained from the Camden County Clerk, and updated our files with a subsequent voter list provided on November 15, 2016 (See Document 2, titled "VoterList111516").

Stampede Consulting divided up the voter list and prepared packets in walking order for the volunteers. We worked with Jim Poland to organize and schedule the volunteers over three weekends. (See Document 3, titled "List of Voorhees Volunteers"). Some of the volunteers walked during the week as well. Over twelve days of walking, we obtained a total of 1,618 signatures, averaging approximately 135 signatures per day.

To verify that the signatures were obtained from current registered voters in the Township, we checked each of the signatures individually and matched them to Document 2, "VoterList111516". Additionally, we checked the names using Stampede Consulting's Voter Mapping Database, and found an additional twenty five registered voters who signed the petition, but who were not listed on the "VoterList111516" Document.

Of the 1,618 signatures that were collected, we could not verify 97 names as registered voters in Voorhees Township. An additional 72 names were found, but were registered under a different address, or last name according to the "VoterList11.15.16" Document. We were able to verify that 1,447 voters who signed the petition are current registered voters in Voorhees Township. (See Document 4, titled "Verified Signatures\_11.29.16"). This number is 41% above the requirement to authorize a public hearing on the matter to dissolve the Voorhees Township Fire District.
