LEAD BASED PAINT INSPECTION REQUIREMENT

To: Voorhees Township Landlords

Date: January 26, 2024

Subject: 2024 Mandatory Lead Inspections for Rental Properties

Pursuant to P.L. 2021, c. 182, all rented residential dwelling units constructed prior to 1978 are required to undergo periodic lead-based paint inspections every 2 or 3 years (depending on type of certification) or upon change of tenant, whichever is sooner, if a Lead-Free Certificate has not been obtained from a certified Lead Evaluation Contractor.

We believe that your rental property is statutorily required to undergo this inspection. In Voorhees, this is a visual inspection of interior and exterior surfaces to identify specific conditions that may be or may become lead-based paint hazards. If you do not obtain certification from a certified Lead Evaluation Contractor, you must have periodic inspections performed by Voorhees Township.

The fee for the required inspection is currently \$50 per inspection, which can be paid by check (made payable to "Voorhees Township") or cash. When submitting the fee, the attached **Lead Inspection Application** form must also be submitted. We strongly encourage all landlords who do not obtain certification from a private contractor to submit their application form and payment by **February 8, 2024** to ensure that your property can be inspected prior to the State's deadline.

If you believe that you are receiving this notification in error because your property is owner occupied, or your property is exempt from the required inspection for any of the reasons listed below, or because you have received a Lead-Safe or Lead-Free Certificate from a certified Lead Evaluation Contractor, you must provide verification via email to rentals@voorheesnj.com or submit hardcopies to Community Development at 2400 Voorhees Town Center, Voorhees, NJ 08043.

Exempt properties must meet one of the following requirements:

- Dwellings constructed during or after 1978;
- Dwellings that have been certified free of lead-based paint pursuant to N.J.A.C. 5:17;
- Dwellings that have been registered with the DCA for at least 10 years and either have no
 outstanding lead violations or have an open inspection & no paint violations;
- Dwellings with a valid lead-safe certification (valid for 2 years).

Please note that any non-exempt rental properties that do not obtain the required inspection/certification may be subject to fines and penalties from Voorhees Township as well as the State of New Jersey.
