

# RESIDENTIAL BULK REQUIREMENTS



Download the Zoning Permit Application from the Township's "Forms & Applications" page. Submit completed form, marked up survey & fee payment to the Zoning Office.

A Zoning Permit must be obtained for all new and replacement improvements prior to installation.

## RESIDENTIAL SHEDS IN REAR YARDS

Area of Shed	Minimum Rear Setback	Minimum Side Setback	Maximum Height at Peak
Up to 100 SF	5'	5'	9.5'
Between 100 & 150 SF	10'	10'	11.5'
Between 150 & 200 SF	Same setbacks as primary structure, as determined by zone (see below).		15'

## RESIDENTIAL ACCESSORY USES & STRUCTURES IN REAR YARDS

Accessory Structures	Minimum Rear Setback	Minimum Side Setback	Minimum Front Setback
All (except for sheds & fences)	10'	Per Zone (see below)	Must be located in rear yard

## RESIDENTIAL FENCES

Fence Height	Permitted in Side Yards	Permitted in Rear Yards	Permitted in Front Yards
Up to 6'	Yes	Yes	No

## RESIDENTIAL BACKUP GENERATORS IN REAR YARDS

Minimum Side & Rear Setback	Testing Permitted	Max dBa at property line	Applicants must demonstrate compliance with all requirements by including a proposed testing schedule as well as sounds specs from the manufacturer.

Maximum height of residential structures = 35'

Minimum side setback for all side-entry garages = 29'
